Oroville Dam Citizens Advisory Commission

The California Natural Resources Agency is hosting its 21st Oroville Dam Citizens Advisory Commission meeting, which is a forum for questions and feedback from communities surrounding Oroville Dam. The public meeting will be held in-person and include presentations and an opportunity for public comment.

Presentations will include annual Oroville facility updates on the budget, prioritization of future dam safety projects, and the status of current dam safety projects and related studies. There will also be brief updates on the US Army Corps of Engineers' Water Control Manual Update process and the Commission's 2023-2025 Legislative Report.
