

# **WSIP Update**

- Quarterly reports received and posted
- Temperance Flat Reservoir Authority resolution received
  - Board voted to withdraw application, decline MCED, asks Commission to direct funds to eligible San Joaquin Valley projects
- \$171 million MCED returned

# Options for using available funds

- Two categories
  - Existing projects
  - Explore new projects
- Existing projects three possible ways to use funds
  - Make Rank 3 Projects whole
  - Possible that two projects could use more funding than requested
  - Apply funds to remaining projects as an inflation adjustment
- New projects three step process
  - Screening
  - Regulation
  - Solicitation



# **Existing Projects - background**

- Commission ranked projects in the application review process
  - Five projects in Rank 2 (no projects in rank 1)
  - Three projects in Rank 3
- Rank 3 projects made up the shortfall in available funding
  - MCEDs were less than applicant request
  - Shortfall of \$146,249,000

Project	Request	MCED	Difference
Sites Reservoir	\$916,620,000	\$816,377,686	\$100,242,314
Kern Fan	\$85,700,000	\$67,537,315	\$18,122,685
Willow Springs	\$123,290,000	\$95,405,999	\$27,884,001



## Existing Projects – background (continued)

 In addition to the Rank 3 shortfall, two projects requested less than their total eligibility

Project	Eligible Amount	Applicant Request	MCED	Difference
Harvest Water	\$280,530,000	\$280,500,000	\$280,500,000	\$30,000
Sites	\$1,008,280,000	\$916,620,000	\$816,377,686	\$91,660,000

- In March 2019, the Commission passed a non-binding resolution that asked a future Commission to consider step-wise
  - 1. Backfilling Rank 3 projects
  - 2. Seeing if projects with additional eligibility had need
  - 3. Additional Solicitation



# Today's context

- Economic hardship due to pandemic
  - Commission emergency regulations
- Existing projects changing
  - TFRA withdrawal decision
  - Sites resizing project
- January 2022 continuing eligibility requirement deadline applies to all projects – existing or new
  - Completed feasibility study
  - Commission finding of feasibility
  - Draft CEQA document
  - 75% commitment of non-public benefit cost share



# **Existing Projects**

- Adjust Rank 3 Project MCEDs to match applicant request
- Funding two projects up to their eligible amounts (beyond applicant request)
- Inflationary bump to all seven remaining projects would treat remaining applicants the same

# **Exploring New Projects**

- Screen projects now
  - Gather some statutory and project information
    - Screening must satisfy January 1, 2022, requirements
  - No commitment of funding for screening
- If project pool reasonable, Commission would need new regulations for second round
- Second solicitation would require similar level of application/review effort as first solicitation

### **Exploring New Projects** (continued)

### Potential schedule

- December 2020 Commission decides whether to start screening process
- January to October 2021 screening process
  - Projects submitted on rolling basis
- October to December 2021 Commission makes feasibility findings for projects if any
- January 2022 if screening indicates a pool of projects, Commission begins rulemaking process
- January 2023 open solicitation
- July to December 2023 review/score/Commission decisions

# **Exploring New Projects** (continued)

- Screening creates some capacity should funds become available after January 1, 2022
- Pursuing a second solicitation will take time
- Second solicitation could consider current water management realities
- Commission could not fund a second solicitation without making decisions on utilizing funds on existing projects
- Three phases for new projects can stop at any phase

# **Options**

- Can engage in screening and take time to understand
  Sites situation before making a decision
- Can apply some funds to existing projects while engaging in a screening process
- Screening does help if more funds become available post January 1, 2022
- Screening time sensitivity January 2022 requirements
