# 8. Assessing a State Role in Financing Conveyance: Presentation of White Paper (Action Item)

As part of the Commission's work assessing a state role in financing resilient conveyance projects, Commission staff will present the white paper for Commission consideration and possible approval.

### 9. Eminent Domain Process Overview

The Department of Water Resources (DWR) has the authority to acquire property for constructing, maintaining, and/or operating State Water Project facilities via the process of eminent domain (Water Code §§11575, 11580), but DWR cannot commence an eminent domain proceeding until the Commission has adopted a resolution of necessity (Code of Civil Procedure §§1245.210, 1245.220). Commission counsel will provide an overview of the Commission's process for making resolutions of necessity for eminent domain proceedings.

Representatives of the Sites Project will provide an overview of the proposed project and update the Commission on the project's current status and progress.

# 12. Water Storage Investment Program: Eligibility Requirements

Water Code §79757 states that a project is not eligible for Water Storage Investment Program funding unless project proponents and the Commission complete several statutory requirements by January 1, 2022. Project proponents must provide completed feasibility studies, draft environmental documentation made available for public review, and commitments for at least 75 percent of the non-public benefit cost share of the project. The Commission must find the project to be feasible. In preparation for projects completing these requirements and the Commission making feasibility findings later this year, Commission staff will provide a process overview of

how this information will be submitted, reviewed, and presented to enable Commission action regarding project feasibility.

# 13. Water Trading: Panel Discussion on Markets and Groundwater Trading

As part of the Commission's consideration of well-managed groundwater trading programs to support Water Resilience Portfolio Action 3.6, a panel of speakers will discuss why markets may be considered by Groundwater Sustainability Agencies, what groundwater trading entails, its opportunities and limitations, and how it is connected to water accounting, allocations, and sustainable groundwater management.
