Commission staff will present their recommendation for supplemental funding for the Harvest Water Program to the Commission. The Commission will decide whether to award supplemental funding to the project, and the amount of supplemental funding.

10. Consideration of Department of Water Resources' Dam Safety Regulations (Action Item)

The Department of Water Resources' (DWR) Division of Safety of Dams (DSOD) staff will present proposed additions and modifications to existing dam safety regulations to the Commission for consideration and approval, pursuant to California Water Code section 161.

Commission staff will provide an update on outreach and engagement numbers, near-term actions, and planning in support of Goal 2 of the Commission's 2025 Strategic Plan, which aims to develop, implement, and evaluate a targeted approach to increasing engagement in the Commission's work.
