Many existing groundwater sustainability agencies (GSAs) need to modify posted notifications to align with new 2018 basin boundaries, reflect new basin names, or clarify groundwater management intent. If your GSA has been affected by a basin boundary or basin name change you should update that information on the SGMA Portal (https://sgma.water.ca.gov/portal/#gsa). There is no statutory deadline for making these changes, but GSAs are encouraged to define exclusive groundwater management boundaries on the SGMA Portal prior to adopting and submitting a groundwater sustainability plan (GSP) to certify that a basin has complete GSA coverage and the legal authority to implement a GSP. A GSP Initial Notification may also need to be revised or resubmitted. To avoid overlap, coordination with adjacent exclusive GSAs may be required before a modification to a posted notice can take effect. Local agencies and GSAs should review the modifications made to groundwater basins by visiting DWR's Basin Prioritization and Basin Boundary Modifications webpages. Basins that have been reprioritized from high or medium to low or very-low are not required to maintain their GSA unless they intend to submit a GSP.

To modify existing GSA information an authorized user must: 1) log into the GSA Formation Notification System; 2) decide that the modifications do or do not represent a material change from the information in the posted notice; 3) select or de-select groundwater basins as applicable to clarify management intent; 4) upload or replace information as necessary, such as GSA and service area shapefiles, hard-copy maps showing 2018 basin boundaries and GSA management intent, and updated resolutions or legal agreements; and 5) re-submit the notification to DWR for a completeness review. A GSA formation notice can also be withdrawn or replaced. The following table shows the name of the GSA, the 2018 basin that the posted notice is now associated with due to approved boundary modifications, whether the basin boundary was modified in 2018, and the 2016 basin that the GSA initially intended to manage. All GSAs are encouraged to review their GSA boundaries to ensure that the areas shown on the SGMA Portal are the areas that they intend to manage.
