The C3 Process


- Desired outcome Network and exchange ideas and resources among counties.

Short-term Response Actions and Long-Term Mitigation Actions

SB 552 requires that each county develop a drought and water shortage plan that includes proposed interim solutions for state small water systems and domestic wells, per CWC Section 10609.70:

(b) A county shall develop a plan that includes potential drought and water shortage risk and **proposed interim** and long-term **solutions for state small water systems and domestic wells within the county's jurisdiction**. The plan may be a stand-alone document or may be included as an element in an existing county plan, such as a local hazard mitigation plan, emergency operations plan, climate action plan, or general plan. A county shall consult with its drought task force or alternative coordinating process as established by this section in developing its plan.

A county shall consider, at a minimum, all of the following in its plan:

- (1)Consolidations for existing water systems and domestic wells.
- (2)Domestic well drinking water **mitigation programs**.
- (3)Provision of emergency and interim drinking water solutions.
- (4)An analysis of the steps necessary to **implement** the plan.
- (5)An analysis of local, state, and federal **funding sources** available to implement the plan.



Short-term Response Actions

Short-term response actions recognize the vulnerability and the need to expeditiously mitigate impacts during the early stages and during ongoing drought conditions and water shortage events.

- Mutual Aid Agreements
- Intertie activation
- Permit Streamlining and Coordination
- Partnership with Non-Governmental Organizations
- Emergency and Interim Drinking Water Supplies
- Dedicated Water Filling Stations by Large Water Purveyors
- Treatment of Available Water from Alternate Sources that Are Not Typically Used
- Packaged or Bottled Water
- Water Hauling or Bulk Water Delivery

Consolidation is often a topic mixed with considerations of these short-term options.

The Survey Says:

Past responses to drought and water shortage emergencies

- > Scream and run around with my hand in the air.
- Some have not had a drought emergency
- > Some are new to their role and don't have knowledge of past experience
- ✓ Coordination:
 - Rely on County OES
 - Water Managers Group coordination
- ✓ Dry well reports:
 - Response and assistance
 - Connected well owners with resources to report dry wells
 - Identified opportunities to deepen/replace wells
- ✓ Conservation:
 - Demand cutback targets
 - Via drought declaration, numerous water use reduction measures
- ✓ Emergency water supply augmentation: hauling water



The Survey Says:

Coordination opportunities to prepare for short-term response

Partners:

- County agencies, GSAs
- **Emergency water supplies:** Developing agreements for water hauling/trucking from suppliers and different counties and planning for bottled water programs.
- Engaging with existing/newly formed task force and water providers
- Looking at MOUs with the large water systems to provide potable water filling stations for hauling

Related efforts:

- Looking for long-term consolidation opportunities while considering interim drinking water supplies.
- Exploring opportunities to help small water systems
- Developing outreach
- Looking for funding for emergency response
- Leveraging the preparation of the DRP for planning

The Survey Says: Key challenges to identifying and securing short-term response actions

Coordination: Building the right partnerships across entities; Multi-department coordination.

Domestic wells: Permitting a potential emergency supply well; Lack of state protocol for dry wells

Identifying emergency resources:

- Source water for the hauled water program
- Identifying equipment suppliers
- Not understanding what options are available.

Engagement:

- Getting Stakeholder buy in and public trust
- Identifying the landowners that actually want the short-term mitigations and how to get it to them efficiently
- Difficulties in engaging small systems

Resources and funding:

- Finding staff time
- Funding for mitigation to address identified hazards

Implementation considerations:

- Implementation pathways since County does not have water rights or water supply
- Rural areas without access to a secondary source or intertie
- Defining thresholds and formalizing triggers, specifying short term mitigation response levels



Consolidation Challenges

Customers do not want to pay monthly water bills

Customers lack technical and operating skills to operate a small water system

Water quality issues

Connection costs from the large system to the main, and then to the building

Customer mindset to save the well for future generations

Lack of space to install treatment systems

Rural sections of the county are a challenge; easier in the city

Short term measures to consider

- 2. Fire Flow
- 3. Condition Assessments
- 4. Communications/SCADA
- 5. Backflow Program
- 6. Levels of Service

2. Financial

- a. Rate Structure
- b. Debt
- c. Grants/Loans
- d. Existing Contracts
- e. Software Systems





Water System Consolidation Considerations

- 3. Regulatory
 - a. Water Supply Permits
 - b. DDW or PUC enforcement orders
 - c. DDW sanitary surveys
- 4. Legal
 - a. Service Area
 - b. Pending/Ongoing Litigation
- 5. Public Outreach
 - a. Public Acceptance
 - b. What is best for the community
 - c. Ensuring everyone is properly informed
