


2026 ENGAGEMENT PROCESS - OVERVIEW



White Paper Development Process

PREPLANNING

- Identify individuals, organizations, and information resources to support topic development.
- Develop a draft vision and white paper outline to guide workshops discussions.

I. VISION FOR THE FUTURE

- Define the desired end state and the key questions to be addressed in the white paper.

Framing the Vision - Key Questions to Explore - White Paper Scope and Outline

II. UNDERSTANDING WHERE WE'RE AT

Establish a shared understanding of the current situation, experience, and capacity.

Current Conditions - Experience and Capacity

III. GAP ANALYSIS

Identify discrepancies between the current situation and the desired future vision.

Comparing Vision and Reality - Underlying Causes of Identified Gaps - Prioritizing Gaps

IV. LOOKING AHEAD

Identify practical pathways to move from current conditions toward the desired vision.

Opportunities for Progress - Barriers and Challenges - Proposed Next Steps



V. PUTTING IT ALL TOGETHER

Draft the white paper to document discussions, findings, and suggested next steps.

White Paper Development – A Collaborative Effort

The Lead Team will work with the DWR Development Team:

- Define the desired end state and the key questions to be addressed in the white paper.
- Support topic discussions, provide vision and direction, identify needed information, and support the development of the white paper.

DWR Development Team

- Provide logistical support and facilitation of working meeting discussions
- Work in coordination with the Lead Team to advance the discussion and address topic discussion and questions to inform the vision and white paper
- Draft the white paper to document discussions, findings, and suggested next steps.

DRIP Collaborative Members and SMEs

- Provide input during working meetings and during DRIP Collaborative meetings to advance the work to develop a white paper.
- Review the white paper

White Paper Development – Roles and Responsibilities

2024 DRIP Collaborative Recommendation: Analyze and clarify the roles and responsibilities of State, local, and other entities that manage domestic wells in coordinating drought response to address water supply losses affecting private wells and community service wells.

This analysis should include:

- **Current Roles:** Assess existing responsibilities in managing domestic wells across the drought-risk management cycle.
- **Identified Gaps:** Highlight inefficiencies in authority, funding, and coordination.
- **Gap Prioritization:** Focus on addressing the most critical gaps affecting drought resilience.
- **Proposed Solutions:** Provide recommendations for funding mechanisms and long-term planning to mitigate risks.

White Paper Development – Drought Indicators and Metrics

2024 DRIP Collaborative Recommendation: Develop a practical drought early warning system in the form of an online dashboard or web application. The system will integrate data across surface and groundwater supplies, reflect geographic and sectoral nuances, and provide actionable metrics tailored to State and local needs. This includes:

- **Water Supply Portfolio:** An integrated view of surface water and groundwater, including complex water supply portfolios (e.g., storage, conveyance, and imports), with detailed data on each element, such as expected deliveries.
- **High Spatial Resolution:** Data at finer geographic scales, ideally at the sub-hydrologic region level.
- **User and Sectoral Impacts:** Addressing distinct needs and effects on cities, small communities, irrigated agriculture, and freshwater ecosystems.

Metrics will track resilience, inform policies, and improve communication among interested parties.
